#### What could the result mean?

- No one really knows!
- Both sides are speculating what the result will mean for our country
- It MAY affect the wealth of the country
- It MAY affect our standing in the world
- It MAY affect our relationship with the rest of the EU

## Should I stay or should I go?

The 'Leave' campaign has focused on:

- Immigration
- Money and the Economy
- The Law



#### **Immigration**

- The 'Leave' campaign are concerned about immigration
- As we are part of the EU it is easier to come into Britain
- However, we are not part of the freedom of movement laws that many countries in Europe have
- Around 165 000 people come to Britain from the EU every year
- The 'Leave' campaign believe that this puts pressure on our country's services

#### Money and the Economy

- Last year we gave £13 billion to the EU and £4.5 billion was spent on Britain from the EU budget
- The rest goes to helping other EU countries
- The 'Leave' campaign also says that EU laws do not help our businesses, for example in farming
- If less people came to Britain there might be more jobs for British people

#### The Law

- Currently we have to abide by laws passed by the EU
- This includes laws on transport, employment, the environment, equality
- The 'Leave' campaign feel that Britain should be allowed to have SOVREIGNTY
- In short, this means British laws for British people

## Should I stay or should I go?

The 'Stay' campaign is focused on:

- Britain being stronger as part of the EU
- Money and the Economy
- Wars and International Affairs



### Britain being stronger in the EU

- The 'Stay' campaign believes that we are stronger with our European partners
- We benefit from being able to visit the EU easily
- We benefit from being able to live in other EU countries
- We benefit from immigration and most come to work
- If we want to change the EU it might be easier from within

#### Money and the Economy

- Some businesses benefit from the trade agreements that being in the EU brings
- Leaving the EU might result in us losing business because trade would be more difficult
- Trade agreements would have to be re-written and we do not know what they would look like

#### Wars and International Affairs

- The 'Stay' campaign thinks that we are much stronger as part of the EU when it comes to deciding how to tackle major incidents like terrorism and war
- They feel that we can join forces to come up with solutions, including sending troops
- They also feel that Britain's standing in the world is stronger within the EU
